Notice of Study Completion Transportation Environmental Study Report Submission

Preliminary Design and Class Environmental Assessment Study Highway 416 at Barnsdale Road Interchange City of Ottawa (G.W.P. 4057-20-00)

THE PROJECT

Morrison Hershfield Limited has been retained by the Ministry of Transportation (MTO) to undertake a Preliminary Design and Class Environmental Assessment (EA) Study for a new interchange at the intersection of Highway 416 and Barnsdale Road in the City of Ottawa (see below Key Map).

The study has examined alternatives for a new interchange to accommodate traffic movements in all directions by providing entry and exit from both northbound and southbound lanes of Highway 416 which do not currently exist. The Recommended Plan and Preferred Design Alternative includes:

- New off- and on-ramps in all four quadrants to accommodate entry and exit from Highway 416 to Barnsdale in all directions.
- New intersections along Barnsdale Road to accommodate new ramp connections to Barnsdale Road.
- · Realignment of William McEwen Drive, Trail Road and Borrisokane Road.
- Accommodation of Active Transportation (i.e., pedestrians and cyclists) along Barnsdale Road through the interchange.

Construction is not currently scheduled. Timing of Detail Design and Construction will be dependent on funding, acquisition of environmental approvals and provincial priorities.

THE PROCESS

The study has followed the approved planning process for a Group 'B' Project under the MTO Class Environmental Assessment for Provincial Transportation Facilities (2000) with the opportunity for Indigenous Peoples and public input throughout. A Transportation Environmental Study Report (TESR) has been prepared to document the existing environmental conditions, potential impacts of the undertaking, required mitigation measures and commitments to future work, as well as consultation activities. The 30-day public review will start on September 28, 2023.


